Introduction

The Security Bureau of the Hong Kong Special Administrative Region Government has launched the Outbound Travel Alert System with effect from 20 October 2009. The system uses amber, red and black to differentiate the levels of risk and aims to help people better understand the risk or threat to personal safety of travelling to 60 covered countries.

Frequency Asked Questions

Prior to your journey:

Q1: If a Black Alert is issued before my Journey, what kind of coverage is provided for me?

A1: If there is an unexpected issuance of a Black Alert for a destination scheduled in the Journey at least one (1) day after the date this policy is purchased as specified in the Policy Schedule (Single Trip) / or after the Commencement Date (Annual Plan) and which is in force at any time within one (1) week of the date the Journey is scheduled to begin, the following benefits are provided for you:

- Trip Cancellation coverage is provided if you decide to cancel the Journey and all travel and accommodation expenses which have been paid for in advance and which are irrecoverable, plus any imposed cancellation fees, can be reimbursed.
- If you choose to cancel your Journey and you do not suffer from any financial loss, you may cancel your travel insurance policy with a full refund of premium.

Q2: If a Red Alert is issued before my Journey, what kind of coverage is provided for me?

A2: If a Red Alert is issued before your Journey, the following benefits are provided for you:

- Trip Cancellation coverage is provided in the event of the unexpected outbreak of a Strike, Riot, Civil Commotion etc. at the destination within 7 days before departure, as set out in the Terms and Conditions. In these circumstances, if you decide to cancel the Journey, all travel and accommodation expenses which have been paid for in advance and which are irrecoverable, plus any imposed cancellation fees, can be reimbursed.
- If you choose to cancel your Journey and you do not suffer from any financial loss, you may cancel your travel insurance policy with a full refund of premium.

Q3: If an Amber Alert is issued before my Journey, what kind of coverage is provided for me?

A3: If an Amber Alert is issued before your Journey, the following benefit is provided for you:

Trip Cancellation coverage is provided in the event of the unexpected outbreak of a Strike, Riot, Civil Commotion etc. at the destination within 7 days before departure, as set out in the Terms and Conditions. In these circumstances, if you decide to cancel the Journey, all travel and accommodation expenses which have been paid for in advance and which are irrecoverable, plus any imposed cancellation fees, can be reimbursed.

During Your Journey:

Q1: If a Black Alert is issued during my Journey, what kind of coverage is provided for me?

A1: If there is an unexpected issuance of a Black Alert for a scheduled destination during the insured Journey and your trip is curtailed as you need to return to Hong Kong directly as a result, travel expenses which have been paid for in advance and which are irrecoverable, plus any imposed cancellation fees, can be reimbursed.

If you choose to continue your Journey, you will still be covered under your policy for personal accident, medical expenses, assistance services etc., subject to the terms, conditions and exclusions of your policy.

Q2: If a Black / Red /Amber Alert is issued and I decide to continue with my Journey as planned, what kind of coverage is valid for me?

A2: If a Black / Red /Amber Alert is issued and you decide to continue with your Journey as planned, you will still be covered under your policy for personal accident, medical expenses, assistance services etc., subject to the terms, conditions and exclusions of your policy.

Q3: If an incident occurs and I am unable to return to Hong Kong as planned at the end of my Journey, can I extend my travel insurance?

A3: Yes, cover will automatically be extended up to a maximum of 10 calendar days in the event the duration of the Journey is exceeded for any reason outside the Insured Person's control.
